

ERASMUS+ Qualification for the 2025/26 Academic Year at the Faculty of Chemistry, University of Warsaw

Basic Rules

1. The qualification for Erasmus+ mobility is conducted through the USOS system. Students eligible for the qualification include those enrolled in degree programs offered by the Faculty of Chemistry at the University of Warsaw, as well as students in co-created programs and interdisciplinary programs, provided they take courses within the field of Chemistry.
2. The deadline for submitting qualification documents (USOS system forms, additional documents) is March 3, 2025, at 16:00.
3. The qualification applies only to universities with which the Faculty of Chemistry at the University of Warsaw has bilateral agreements.
4. Submitted documents will be reviewed and assessed by a committee consisting of:
 - o Dr. Kamila Zarębska (Chair),
 - o Dr. Marcin Strawski (Program Coordinator),
 - o MSc. Kamil Gryckiewicz (Student Government Representative).
5. Appeals against the committee's decision can be made in accordance with the regulations outlined in the document *General Principles for the Qualification of Students and Doctoral Candidates for Erasmus Scholarships for Partial Studies (SMS) at Universities in EU Member States, Associated Third Countries, and the United Kingdom for the 2025/2026 Academic Year*.
6. The main criteria for application evaluation will be:
 - a. The GPA from the previous academic year, with a minimum required average of 3.49 to receive the scholarship.* Conditional enrollment in the study stage at which the recruitment takes place is allowed, but only in cases where one subject has not been passed (as of the application submission date).
 - b. Verified language proficiency at the level specified in the bilateral agreement.**
7. If the number of applicants for a given partner university exceeds the number specified in the agreement, the program coordinator will attempt to obtain approval for increasing the number of participants. If such approval is not obtained, priority in the qualification process will be given to:
 8. a. Students participating for the first time,
 9. b. Students from groups with fewer opportunities,***
 10. c. Students with a higher GPA.
11. The stay at the host university should result in fulfilling the academic requirements of the respective semester/year of the study program. Applicants must prepare a study plan at the host institution that allows, under the regulations outlined in the *Vice-Dean for Student Affairs Ordinance No. 1/2021 of the Faculty of Chemistry, University of Warsaw, dated September 14, 2021*, for the recognition of specified courses as equivalent. This will ensure that the corresponding ECTS credits and grades are transferred.
12. Any matters not covered above are regulated by the document: *General Principles for the Qualification of Students and Doctoral Candidates for Erasmus Scholarships for Partial Studies (SMS) at Universities in EU Member States, Associated Third Countries, and the United Kingdom for the 2025/2026 Academic Year*. This document is available on the website of the International Relations Office.

- A GPA below 3.49 is allowed but will result in the scholarship not being granted in the primary qualification round. This status may change depending on the applicant's improvement in academic performance and the current financial capabilities of the International Relations Office.
 - ** Acceptable language proficiency certifications include certificates issued by the UW Foreign Language Teaching Center, positive results in language exams taken at UW, and certificates listed in the *General Principles for the Qualification of Students...* document.
 - *** Students with fewer opportunities include students and doctoral candidates with disabilities, as well as students receiving social scholarships at UW at the time of qualification.
